

End-of-Sale and End-of-Life Announcement for the Cisco Catalyst 2960 and 3560 8-Port and 12-Port Switches

Cisco announces the end-of-sale and end-of life dates for the Cisco Catalyst 2960 and 3560 8-Port and 12-Port Switches. The last day to order the affected product(s) is July 29, 2013. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

One month after the end-of-life announcement, the price of the switches listed in this announcement may increase in order to accommodate the fluctuating component costs for those products.
